Buy-Back Transaction

Background/Description of the Disclosure

As disclosed last July 27, 2022, the Board of Directors approved the extension of the common shares buy-back program of Concepcion Industrial Corporation (the "Company") from September 9, 2022 to September 9, 2024. This program was originally approved last September 9, 2019 and was scheduled to run from September 10, 2019 to September 9, 2022. The extension authorizes the Company to repurchase up to the balance of Php177,837,818.00 of the authorized buyback amount of Php300,000,000.00.

The buyback program will not involve active and widespread solicitation from stockholders and will not adversely affect the Company's ability to fund any of its prospective and existing projects/investments. The buyback program will be executed through the open market by means of the trading facilities of the Philippine Stock Exchange and implemented by the Chairman and CEO, and the Chief Finance and Operating Officer of the Company.
